The memorial will cost \$350,000 and being funded \$75,000 by the city of Lake Forest, \$75,000 by post #264 and the rest to be raised through donations.

Our Steve Potsic volunteered to review the necessary paper work to confirm that we can donate to the memorial without IRS problems.
